

AHR Meeting Minutes 2024

September - AHR Board Meeting Minutes - 9/17/24, Submitted by Tara Williamson

The meeting was called to order by Brian.



The treasurers report was given. Stacey had requested information regarding a Kim Morrisee, as she was due a refund of sales tax from the auction and her address had come back undelivered. Kathy did some research and suggested a PO box which would then be given to Stacey to try.

Brian called for a motion to approve the treasurers report. Kathy so moved, and Anne-Laure seconded. Motion passed.

Futurity- Erwin reported that there were 26 entries for the Sport Futurity. Wade Wilcox will be the photographer.

Inspection- 6 Horses are committed with 4 being Mares, 1 Stallion, and 1 Gelding.

Expecting to start at 9am with measuring and then start the inspection about 10:30am and running until 1pm roughly.

Publications- newsletter is laid out, almost ready to print. 28 pages roughly expected for October. Social Media is going well with consistent posts and a significant uptick in engagement. The California Inspection results, hitch futurity, Twin Birch show results and a couple member-written articles will be featured.

Website- Some things came to light regarding the business that was hosting our website that instigated a needed change. Through a contact of Erwin's, we can have the site hosted now for free, and the previous website host is refunding us \$1600 as well as providing the back ups of the site. The new company seems to be going smoothly, however we have asked very little of them to date. Passwords will be changed once we are confident that the transition is complete.

December will be the next newsletter, hopefully featuring member show results and accomplished goals that they would like to share. Election- election materials are to the printer, and they are working on printing, stuffing and mailing.

In-Person Meeting- Hoping to schedule at the Cleveland Marriott for the beginning of November.

Old Business- Chupps were advised that the contract would not be renewed to send the newsletter through the Halfinger Journal. They did not respond. No further business. Kathy moves to dismiss and Erwin Seconds. Meeting Dismissed.

October - AHR Board Meeting Minutes - 10/15/24, Submitted by Kendall Vaitkus

Brian called meeting to order at 8:02pm. Everyone present. Tara read minutes from August meeting as a recap. No questions. Erwin motions to approve minutes. All in favor, motion carried.

Treasurer's report: No questions on this report. Kathie motioned to approve, it was seconded and all were in favor. Motion carried.

Futurity: Erwin said they said about 25 horses. Everything went fine and people seemed to enjoy themselves.

Inspection: Kathie said there were 5 horses (3 mares, a stallion and a gelding). Results have been updated in digital horse and on the website. Certificates have also gone out.

Publications: All good with the October Newsletter. It was emailed on 10/1/24 and should be in mailboxes this week. Next project is the 2025 calendar which brought several submissions. The new website company (Infinite Digital Solutions) is doing this completely free for the AHR since we are a non-profit. They are very nice and Kendall is excited to work with them. They said they are willing to do all website projects big and small.

Nominations and Ballot questions: Brian has had 3 calls about the Eastern Director vote being on the same ballot as the At Large Directions. Tara explained that the Eastern votes coming back will be separated out by their return address and counted separately. Then they will be added in to the whole pile to be counted for the At Large ballots. Two CPAs will be used and each will count both piles separately. The issue of voting for 3 directors at large vs 4 has been addressed on social media and on our website. Tara will reach out to the Suttons to see if they will oversee the CPA vote counting.

Old business: Brian is trying to set up the in-person board meeting. It's been difficult with everyone's schedule and is looking like we will need to push it to January. Everyone agreed.

Motion to adjourn made by Erwin and Seconded by Robert. Meeting adjourned at 8:28pm.

Meet Kyle Ford!



Before telling you a little about myself, I wanted to first thank you for the honor of being chosen to serve on the American Haflinger Registry Board. It is an honor, and I am humbled by your trust. It will be my complete focus to work to promote this worthy breed and focus on what is best for ALL AHR members.

My background is pretty much all equine focused. My first two horses were purchased when a family friend agreed to sell me the gelding I wanted, for less than he was asking, only if I took the mare that was with him. At 8 years old I had negotiated my first horse deal and was thrilled. Sweet Lou was a 15-year-old quarter horse and was the horse that made me realize that horses would be an essential part of my life. For a few years I ran barrels and poles as my mom took me to draft shows trying to convince me that I should be a teamster. But when I saw Reining at the All American Quarter Horse Congress and then made a trip to Shawn Flarida's, with my grandfather, where I rode a reining horse for the first time any aspirations my mom had of me being a teamster were gone. I was going to be a Reiner. My first Reiner was a horse named "Skeeter Fudge Bar." He was the first of many horses to come

that I showed in my reining career. When my parents purchased their first Haflinger's I knew little of the breed, but it did not take long for me to see talent and diversity in these horses. Not to mention their incredible willingness to please. The more I was around the breed the more I saw the value in the breed. Especially after meeting my girl friend who has been involved in jumping since she was 8 years old as well. Cassie purchased a horse by the name of Appey's Oliver from a client of mine for whom I was handling the sale of the horse. This was a world that I knew nothing about and that the Haflinger breed absolutely excels in. Learning this discipline from her has been an awesome new experience.

Currently, I work for the city of Whitestown outside Indianapolis. The hours allow me to have time in the evening to train. Primarily my focus is training Haflingers, but we will occasionally take other breeds if someone needs help.

In closing, I want to express something that I feel strongly about. After riding a lot of horses with numerous successful trainers that I have had the privilege to learn from, and still learn from, I am positive that the Haflinger horse is an athletic, trainable, willing riding partner that is worth more than what the market is now dictating. It is frustrating to me that others don't see the superior value of this breed and I sincerely hope that while serving on the Board that I can assist the other Board members to help others see the true value of the Haflinger horse, and build a bright future for the breed. After we one a third in the eq on the flat, we packed her up and went home. Once we were home, Marvi began having difficulties with her willingness to jump. She began refusing more often and was over all the most tired she had been in a long time. Marvi and I took more trips off property that didn't require her too jump. We went on a few trail rides, showed at a pleasure show (which I decided to enter in a western pleasure class), and we even took her on a few trips to my house! In August 25, 2024, we brought her to another one day schooling show. Marvi did not enjoy her time there and refused almost every jump. Carriage Springs Farm Registered Haflingers 2024 in Review

This year was a very busy and rewarding year for our Registered Haflingers and team members of Carriage Springs Farm. To start the year, the hitch wagon was refreshed by Jake Schut to change the color from red to a multicoat of red metallic flake over black so that in the light the color changes through many shades of red; so many compliments; it was a great color choice.

March through early May had the breeding activities in full swing with foals arriving and mares being bred for next year and making decisions on who to breed in 2025.

Training and conditioning the show string started in January. Horses were ready for their first show in June, which was the Wilmington Classic at the World Equestrian Center in Wilmington, Ohio followed closely by the Northern Ohio Draft Pony Association (NODPA)

Show at the Richland County Fairgrounds in Mansfield, Ohio.

July we travelled to the 25th Annual Great Lakes Haflinger Association (GLHA) Show at the Allen County Fairgrounds in Lima, Ohio and then off to the Derrer Ranch Classic at the Topeka Livestock Auction in Topeka, Indiana. Had a great experience at the Ohio State Fair where our 4 year old mare, Naoma's Nightingale HCS won Best of Haflinger Breed; our 3 year old stallion, Wagner 2SH won Grand Champion Haflinger Stallion and our 3 year old gelding Bravado's Bamm Bamm HCS was named Grand Champion Haflinger Gelding.

August started out with our first night show at the Lake County Fair in Crowne Point, Indiana. What a fun experience for the horses and the team members. All of the lights of the rides and the concessions which surround the show arena made for a thrilling venue to drive the horses. The month continued with the Illinois State Fair followed immediately by the Indiana State Fair National Haflinger Draft Show in Indianapolis, Indiana. The horses did great in halter and in driving classes.

September was the LaPorte County Draft Horse Show in LaPorte, Indiana where Gale was named Best of Show, Wagner was Reserve Champion Stallion and Bamm Bamm was Champion Gelding in the halter classes. Driving classes were exciting with some great competitors in attendance. We were given the opportunity to compete at the Vernon County Fair Draft Horse Show in Viroqua, Wisconsin. The arena was the race track and it was a blast. The stands were full of fans who never stopped cheering; the weather was beautiful and the horses and team members had a great time.

The Big E National Haflinger and Hitch Championship Pony Show at The Eastern States Livestock Exposition in West Springfield, Massachusetts took place September 27-29, 2024. This was the first year Carriage Springs Farm Registered Haflingers qualified for this competition. Over a thousand miles from home made the experience a bit of an adventure; first time for a huge crab sandwich at a competition. It was delicious!! The crowds were very encouraging even as we drove across the midway on the journey to the arena. November 15-16 was our final 2024 competition at the North American International Livestock Exposition in Louisville, Kentucky. Weather during November can be very unpredictable and stalls are not completely enclosed so when the weather is good it is something to celebrate. And this year the weather for the 2 days of competition was excellent even though the 2 days before when competitors were arriving it was pouring down rain.

The stats are 14,000 miles and 30 drives of the six horse hitch in competition and lots of ribbons and friendships made and renewed. With gratitude for a solid 2024 we look forward to an even stronger 2025 when there will be some more 3 and 4 year olds joining the hitch from our home bred herd. 


