It has been a busy fall! We had our Face to Face AHR meeting on November 8th in Cleveland Ohio. Half of us were able to attend in person but the other half attended by zoom, in large part due to the airlines cancelling numerous flights due to the Government shutdown.

First order of business was to elect officers. I was elected President for the upcoming year, Glenn Yoder was elected First Vice President, Erwin Slabaugh is Second Vice President, Dave Ayers was elected Treasurer, and Pam Hess was elected as Clerk to the Board.

New Board members Jessica Taylor, Michelle Harper and Glenn Yoder were welcomed to the Board.

Stacie Lynch with Digital Horse gave a very in-depth demonstration of the capabilities of the online program for members. Things such as transferring horses, keeping breeding and health records and many other features that can make record keeping so much easier.

There was lengthy discussion on a two-year-old breeding stallion proposal. Final determination on the rules are simply to change the breeding age of stallions from three years old to two years old. Also new: Fees for new stallion license have been raised from \$300 to \$325 and stallion yearly renewal license fees were raised from \$30 to \$40. These new fees take effect January 1, 2026.

We are looking for someone to take the coming vacant position of Marketing Editor. Kendall Vaitkus will be retiring at the end of December. We hate to see her go as she does such a great job. But we understand that sometimes you just must step back and spend more time with home and family! Attention Rule Change

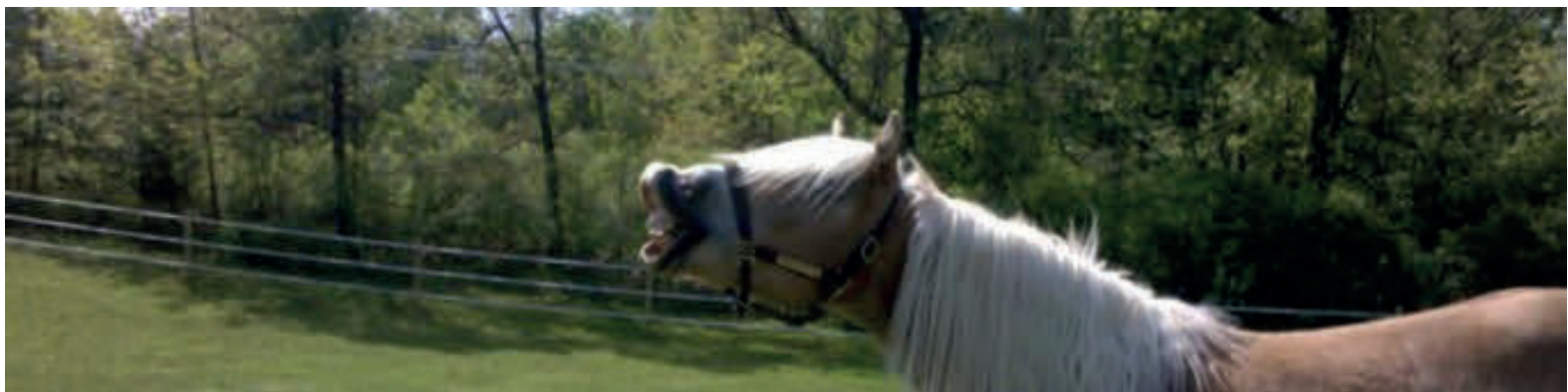
Effective January 1, 2026

Please find below two rule changes concerning stallion breeding age. For questions, please contact the AHR Board of Directors at Board@HaflingerHorse.com.

Basic Rules, #7: *Animals may only be registered if the stallion was deemed 2 years old or older and the mare was deemed 3 years old or older at the date of conception of foal. This applies to stallions born 01/01/2024 and after.*

Basic Rules, #17: *An owner may apply for licensing of a breeding stallion any time after the stallion is deemed a 2 year old. This only applies to stallions born 01/01/2024 and after. To be licensed, a stallion must be physically inspected by a licensed veterinarian and certified free of cryptorchidism and free of monkey mouth or parrot mouth. The stallion must also be DNA identified and that information filed in the records of AHR.*

Note 1: Applications for Transfer received more than 90 days after date of sale will incur a penalty of \$25.00 in addition to the regular fee.

Note 2: Above prices are payments by cash, check or money order in US funds. Visa and Master Card accepted. Add 3% processing fee on all credit card payments.

Registration of domestic foals after calendar year of birth – \$50 for the first year and \$35 for ever year thereafter; DNA required.

****Reminder on Stallion Licensing** – All licensed stallions require DNA testing. Foals born on or after 1/1/99 must be sired by a fully licensed stallion in order to be registered. Stallions licensed previously by either HRNA or HAA that have vet inspections (absence of mouth defects and cryptorchidism) and DNA type on file are fully qualified with AHR. Renewal fee due annually by October 25th after year of initial licensing.

Artificial Insemination (AI) – Foals born after 1/1/98 that are a result of AI with semen that is transported from one farm to another must have proof of parentage through DNA typing (foals registered as geldings excluded). All foals from frozen semen must be DNA typed.

Minimum Breeding Age – Effective 1-1-2026 the minimum breeding age for a stallion is 2 years old and for a mare is 3 years old.

Age is determined each January 1st after year of birth. A foal is deemed 1 year old on January 1st following year of birth.

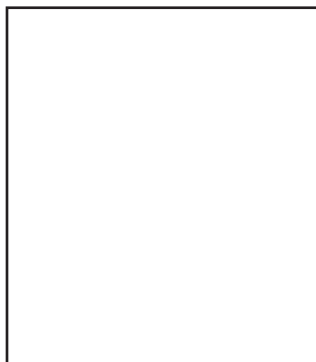

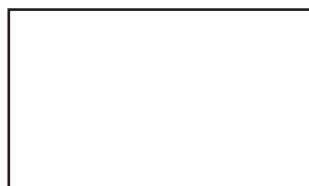

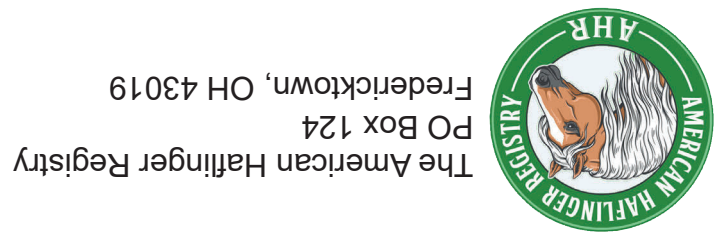
